Called COB Tom Stone to podium. Presented checks for US Jaycee Mission Inn, the charity of choice, for \$1,000 and a check for US JCl Senate Foundation for \$1,000 for his presentation. COB Tom presented check for Foundation to Doug Hinker and check for Mission Inn to Barry Botten.

Executive Board made recommendations for disbursements to be made from Contingency Funds not included in the budget just approved. Recommended to spend \$1,500 for President's Pins, which is currently due. A line item will be included in the budget for \$200. Recommended to place \$3,400 towards a 30th Anniversary Celebration to be acknowledged at both the beginning and the end of the US JCI Senate 30th year. There was \$3,000 we recommended be put aside for anticipated International Meetings, knowing that we have an Area C Meeting scheduled in Atlanta with no budget. In the near future, we potentially will see a World Congress.
