Ken mention the finance committee met yesterday and the minutes are at the back of the room. - One of the functions of the finance committee is to look at the actual budget and compare to actual performance. We are happy to report the raffle had earned \$34,455 in relation to a budget of \$26,500. Largest membership Region is Region 5with 1791 members, Region 6 is second with 1337in Membership. Our largest state is Illinois with 700 members. Region 5 & 6 had 94% retention. The states of MD, MT, KS, LA, DE, MS and D.C. had 100% KY led with +81 ytd with Virginia following. On the Financial status prior to this meeting as of June 15, 2003 we was \$18,400 income over expenses. Tremendous job. Great job by the raffle committee, Mentors sales were up, product sales were up, and our credit card program. Any questions. The interim proposed budget was at the back of the room for distribution. 2004 Annual Meeting- Charleston SC Bid - John Price reported that the bid review committee had some reservation about the bid because of some financial difficulties that we were afraid might cause some hardships to South Carolina and in a split vote sent it on to the executive committee to take a look at. The executive committee also expressed some reservations with this bid, not because we don't want to go to South Carolina, not because we don't love the South Carolina Senate, but because there are some financial considerations here that might cause them some severe hardships if anything should happen to go south on this bid. At this time I call on Jerry Godwin #33623 from South Carolina - "Good Morning, I appreciate the bid review committee and the executive committee seeing what we have seen. But in order for us to have it in South Carolina, and we want to have the convention in South Carolina, the hotel that can accommodate you knows that so therefore they have applied some things that are a we bit unusual. It's not the old game where I will fill your hotel and you will give me so and so. They are not playing that kind of game. But we have done so strong research and so forth and we feel we can make this happen. The only thing that I would ask of you in order to make it happen is come to Charleston. If you come you will support us. This problem won't be a problem. If you decide not to come and not to register and get your room then all of a sudden you may not see me at any more conventions because I probably won't be able to afford it. We can get into specific details if you like but that is what it amounts to. The hotel really don't care if we are there or not". Tours planed include going to a Magnolia Plantation and Gardens and we have Patriots point. Again you will be the key to our success you come and visit us. The rooms are going to be \$99.00 per Night. The registration with the executive committee approval will be at \$100.00 with what we have planned it should be \$210.00 John Price- One thing we did do and it is related to some policy changes that you will be hearing about a little bit later is that we have swung this convention around so that it starts in the middle of the week ends on the weekend so that you will experience a Saturday stay and perhaps get a better rate on your airfare. June 15-20, 2004 is the proposed dates. Moved by North Carolina, Seconded by Missouri to accept the bid. Any discussion. Is there any discussion on this bid? Motion passes. Administrative Vice President's Report- John L Price #36383 Policy Revisions - This organization operates with Constitution, By-laws and Policy. A major portion of the policy deals with how we conduct our meeting. We have known for several years the Jaycees were changing their schedule and for many years of course we meet in June with them and we met in Tulsa with them. As we were making these changes we also noted that it is getting more and more difficult for states to bid these meeting. It is getting tough for host organizations to provide the kind of hospitality and hotel services that you expect at the prices that we have been paying. You people, all of us, get a tremendous deal because of the creativity and enterprise of many of our host organizations but it is getting tougher and tougher to do it. So the bid review committee, I have to commend Judy Jones, Mary Sawyer, Vicky Dempsey and Steve Sutherland, has come up with a new policy. The new officers and presidents will be receiving copies of the new policy in the new officers handbooks. Some of the changes- Bid letters are in policy, letters of intent can be filed so that we know in advance if there are no letters of intent then the AVP can go out and beat the bushes and find some. Hospitality- Minimum hospitality, The Days of three squares a day every day at least for some of these convention is beyond the financial capabilities of some organization and some states due to union

laws, liquor regulations, hotel regulations and various other factors to be able to provide you three squares a day. You notice we are in a hospitality tent as we were in Dayton. The reason so that we can provide you with the kind of hospitality you were expecting that we could not provide inside this building. The point being in some states you could do it inside this building in many states you could not and in many states you couldn't even put this tent up. Also since the Jaycees are not meeting with us anymore we don't have to meet on a Sunday to Thursday. We decided it might be better the meet in a way that carries us to the weekend we also have included in there the possibility of shortening the Convention to four days. Should the host committee would want to do it that way. We have also changed some of the late fees. They have been raised. We have also reduced the amount of the registration that goes to the US JCI Senate in the hope of more support for the hosting committee so that they can provide better hospitality. Those are some of the main changes, this does not require a vote of the Board of Directors just the Executive committee. This is so that you might understand some of the changes. The executive committee approved the policy, yesterday afternoon. Are there any questions? Thank you.
