MOTION TO APPROVE THE ANNUAL MEETING MINUTES made by North Carolina, seconded by Georgia. Ask for discussion, hearing none called the vote. .Motion carried by a voice vote-no dissentions.

Joe A thanked everyone who helped with getting the directory out and got their Scene article in on time. There are corrections to the directory since it was published. The corrections available this weekend. You have the opportunity to purchase additional copies of the Directory for \$5.00 as well as a subscription to the Scene for \$15.00. Thank you very much, let's have a fun year!

Jack made a presentation to Joe A, thanking him for all of the work done so far.

Treasurer's Report:

Ed Hart # 28991 reported that the membership numbers are in the back of the room. Membership totals for the first Quarter 1609 Billed, 1430 Renewed, 160 New, Dropped 179, resulting in minus 19 for the quarter. Membership number right now is 7552. Ed asked if there were any question on membership numbers for the first quarter. 2nd thing is finalization of the proposed budget. Ed asked for a motion to approve the budget. MOTION TO APPROVE THE BUDGET by New Jersey, seconded by Missouri. Open for discussion, hearing none assumed you are ready to vote. Motion carried by a voice vote

Ed called on our associate Treasurer Jim Rose #30309 for the Audit Report.

We have gone thru the books everything is in good shape. All of the accounts for expenditures are well documented. Everything was appropriate and within the budget There are copies of the report on the table outside. Along with a listing of the separate accounts and how they relate to our budget.. We made about \$7000 by running the convention by ourselves as compared to about \$2000 we would generally make running with the Jaycees. MOTION TO APPROVE THE AUDIT REPORT made by Iowa, seconded by North Carolina. Any discussion or questions of the audit? Question called for. Vote in favor of calling the questions? Passed. Voting on the main motion to approve the audit report. Ask for discussion, hearing none assumed you are ready to vote. Motion carried by a voice vote. Thank you Jim, we appreciate all of you efforts.

Ed then called on Finance Committee chairman Ken Clements #45944.- Recommendation of Finance committee, as well as the executive committee, that the World Congress Committee's budget be increased by \$2500 (money that have already raised) and an additional \$3500 be added to their budget. This would make a total budget to use for the World Congress of \$13,500. This will also be with the understanding that if they raise additional revenue on their own that they be allowed to use those revenues as part of their budget. An additional recommendation was made to allow (out of our surplus from last year) \$200 for each of our last years ambassadors. Ed announced that the chair would entertain a motion to approve the recommendations. MOVED by Pennsylvania, Seconded by California to approve the recommendations. Motion carried by a voice vote. That concludes the Treasurer's report. Jack made a presentation to Ed, thanking him for all of the work done so far.

World Congress- Las Vegas 2002

We will be taking them off site to a Barbecue. Tuesday night is the Senate Banquet. We are trying to do the best we possibly can. New Business:

US JCI Senate/US Jaycee-Meeting Agreement – Jack M Pasquale #32806

As you know one of our efforts has been to attempt to meet with the US Jaycees again. It has been the hallmark of my efforts as the President this year to make that happen. We had tremendous activity and commitment on part of the US Senate members and a number of US Jaycees members to make this happen. We got a commitment from the Jaycees to meet with the Senate and have asked the Senate to make that commitment to meet with the Jaycees. Senators this is important, we profess that return the favor is our primary goal to the Jaycees. Let's give attention to this please, it too important and we can't mess it up. The reason we can't mess it up is because it takes a change on our part too. We are going to have to do some things differently than we have done before. But I'm sure we can all do it. The Senate has a Fall Board meeting in 2003 the Jaycees have asked us to join with them for their National Meeting in September. They have already committed to a location. I have asked the body to approve a resolution which we will bring forth that will allow us to meet with the Jaycees in 2003 and we have a commitment from the Jaycees to meet with the Senate, at a Senate located site, for the year 2004. The Jaycees recognize that the Senate wants to help them, and can help them. They have made a commitment to say we will do it, we really will do it will you do it with us? I'm asking you, will you please do it with us.

I've asked the legal counsel to site/give you this proposal that has gone thru and been approved by the Executive committee for a presentation to the Board of Directors.

Legal counsel – Steve Sutherland #27073- The Executive committee recommends the adoption of the following resolution.

"Whereas, the USJC desires to convene a meeting during the year at a meeting site with the US JCI Senate; and

Whereas, Article XVI Section 3 of the USJCI Senate By-laws provide on a best effort basis, that the USJCI Senate desires to convene a meeting (s) at a joint meeting site with the USJC; and Whereas, USJC has proposed we convene our meeting at a joint meeting site in Anaheim, California in September 2003 and agree to meet at a USJCI Senate selected site in September 2004; Therefore, be it resolved:

The USJCI Senate will convene their fall Board of Directors meeting in September 2003 in Anaheim California coinciding with the USJC meeting and the USJCI Senate will select the site for the USJCI Senate Fall Board Meeting and the USJC Meeting is September 2004."

NORTH CAROLINA MOVES to accept the resolution. Seconded by California. Discussion? There will be a standard Senate bid process for 2004. Our meeting will be a normal three day meeting. The Jaycees will probably be a 5 day meeting, as it is their National meeting, starting on Wednesday. In the past there was a fee we paid to the Jaycees as part of your registration that won't happen at least for the next year. But I would assume if you want to participate in the Jaycee meeting you will have to make arrangements with the Jaycees with some type of daily pass or with their registration. The same holds true if the Jaycees wish to participate in our Senate events. Date is set by bylaws, their bylaws say we have to met in September and our Bylaws say we have to met in September. California Senate has agreed to host the meeting with the Region X JCI Senate should this resolution pass. We have verbal agreements for beyond 2004, we expect policy changes to come up in Atlanta at our winter board meeting. The anticipation is that we will have alternating years, Senate will pick one year, Jaycees will pick one year. The meeting will be moved across the country. Verbally we have commitments from the Jaycees out to 2006. I think you can see the commitment is there to make this happen. Any other questions? Calling for the vote. Motion carried by a voice vote-no dissentions. Thank you!

Constitution /By-Laws-Bill Potuchek #35278

There was proper notice provided for the passage of by-laws copies of it were published as well as copies on the back table the proposed change was recommend by the executive committee last night, passed unanimously by constitution and by-laws committee last night is as follows;

Change In Accordance with Article XX Section 1

Amend Article XVI Meeting as follows:

Add at the end of section 1

As concerns the Board Meetings, the above mentioned inclusive periods may be extended up to fourteen (14) days from the last weekend in September and the last weekend in January, respectively, to facilitate a

joint meeting with the United States Junior Chamber of Commerce in accordance with Section 3 of this Article.

FALL 2003 BOD MEETING BID - AVP John L Price- Convention Bid & Review Committee, reviewed a bid for 2003 Fall BOD Meeting passed it on to the executive committee meeting which has recommend it on to you for your consideration. The Bid is from California. MOVED TO ACCEPT the bid of California by Texas and Seconded by Georgia. Presentation of the bid package by CA JCI Senate representative Doug Meyers #21511. CA is excited about putting on this board meeting although we've only had maybe 6 to 7 weeks to work on it. We have an excellent Hotel, Sheraton Anaheim Hotel, close to Disneyland and Disney's California Adventure. Meeting to be held September 26-28 in conjunction with the Jaycees National Convention. Rooms are available before and /or after if you want to stick around for the numerous attractions available in Southern California. Registration cost is \$55. We anticipate a one day pass cost of \$20 not including lunch and just includes hospitality. Registration deadline will be postmark September 1, 2003. Late fee of \$10.00. There will be a sit down lunch on Saturday. Snacks and light food will be available. Room Cost is at \$90.00 per night. There will be a \$25.00 housing fee if you are not staying at our hotel. (we have to have a set number of room nights or pay a high corkage fee) Reservations will be made thru the Hotels 800 number, Airport transportation is available thru the Airport bus. Policy Change - Legal counsel – Steve Sutherland #27073 Approved by the executive committee last night.

Article 1 (P-4) (Fall & Midyear Board) add (under finance):

"A partial daily registration of up to \$20.00 may be assessed by the host organization committee with \$5.00 of the daily fee going to the US JCI Senate and the balance being retained by the Host Organization committee. Said fee includes hospitality only."

In the next 90 days the Convention and bid Review Committee will be going thru a complete review of the policy because obviously there are going to have to be major changes because of what we are doing with the Jaycees. Hopefully we will have some proposals ready for you in Atlanta.

Fall 2004 BOD Meeting Bid. In accordance with our current By-laws it is to early for us to be able to bid that meeting. However I would appreciate a letter of intent form any state wanting to bid this meeting. Obvious we will be going over those and deciding where we are going to meet with the Jaycees. We have already received a Bid for this 2004 meeting, we can't vote on it As soon as we are able to accomplish a By-law change to allow this body to vote, we can. In the meantime anyone else get information into me 45 days before Atlanta.
