Treasurer's Report by Ed (Jake the Snake) Hart #28991

(2) reports on table, first is white cover copy is final from last year, second is yellow copy for beginning of this year. Jim Rose in attendance to discuss audit.

(President John Price acknowledged arrival of Region III VP). Audit report by Jim Rose #30909, Jim noted that books were in good shape and that Ed has done a good job. Looking at the report on page 2 is the balance sheet shows where we stand, most of our assets are in cash, \$100,071, Current Liabilities, reserves for the Foundation and JCC Charities are unpaid for the year leaving a net worth of \$101,049. Next page, Revenues of \$118,898 versus a budget of \$94,600. Expenditures of \$111,155 leaving a surplus of \$7,743. Last two pages shows Program Revenues and Expenditures line by line, publications were over budget due to increased advertising, products substantially over due to World Congress and hard work of the Products Chairman, and Reverse Raffle budget of \$26,500 versus income of \$35,986. Expenditures, nothing out of control, publications under budget, products were over because sales were up, everything else was pretty much inline. Items that have dashes indicate area where no expenses were turned in. The next page is the Administrative Expenditures, were in control because the Treasurer makes sure he does not over pay anyone. Actual versus Budget items were inline with exception of a couple of line that were expenses that were not submitted on time, overall it looked good.

Treasurer Ed Hart #28991 entertained a motion to accept, Motion by John D Olson #35308, Second by Joe A Souza #27511, Audit accepted. 9

Finance Committee today, a couple of things that were discussed that will impact the budget, we will have to make some changes in the raffle, information is going out on that, also discussed making it easier for Senate membership to purchase supplies, they can do it online and be able to use the Pay Pal system this will allow to make purchases without waiting for a meeting. The Finance committee meeting was good and well attended.

Membership - If you go to the Yellow colored sheet, yellow to go along with this years color, really good first quarter, (Ed) I want to thank everybody, I particularly enjoyed the emails from Paul Carney concerning dues billing for Massachusetts, however I will mention that the last one received was Washington, they went from the outhouse to the penthouse, they not only had their check for the September dues but December as well so they are ahead of the game. After making some adjustments because the database is still not 100% correct we started the year with 7813 in membership, we had 1511 for 19% of our membership due in September we renewed 1389 for 92%

retention, tremendous job. We dropped 122 of our friends but we brought on 195 new ones, for a growth of 73 or approximately 1% of our total membership of 7886 and I am not a historian but we should be close to a record number. Historian Mike Sawyer #36403 did not know what the number was but would investigate. Thank you to all of the VP's for getting the dues in on time. The next page shows the largest state, regions, new member adds, new member adds by region, growth states, and growth regions. Illinois continues to lead with 701 they grew by 1 but they still grew, Michigan second, California within 4 of taking over second place, Ohio's fourth, Indiana is at 256 and says they will be at 300 by the end of the year. I think we can be at 8000 with some hard work by asking the Jaycees for new Senators, and finding old Senators to come back to the family. Again, thanks you for all your hard work.

2003-2004 Budget - on the last page, bottom line for the first quarter is we spent \$5086 more than we took in, the reason for that simply is we had some up front costs, insurance, last year the bill for the insurance didn't come in until the 24th of September I was actually given the bill in Denver which does not provide time to pay it in the first quarter, we made changes so instead of September 12th its due now on August 1. We do front money for registrations to the state hosting the national convention to help them get started. So, additional money had to go out the first quarter. Changes to the Proposed Budget, under the income side on the left under the Presidential Raffle cross out \$29,000 and put in \$32,000, Total Fundraising cross out \$38,000 put in \$41,000, go to Total Income cross out \$102,575 put in \$105,575, go over to the Expense side under Operating Expenses, under Presidential Raffle cross out \$4,500 and put in \$7,500 at the bottom for Total Operating Expenses cross out \$26,050 and put in \$29,050. In Total Expenses cross out \$102,575 and put in \$150,575. Also, under Allocations change 35th Anniversary to 40th Anniversary. Chair will entertain a motion to accept, Motion by Jim Trenary #39654, Second by Glenda Newberry #45988, Question called by John D Olson #35308 (Question called) motion passed, Budget accepted.

It is hopeful that the states will take this to their states and get this up and running to generate a revenue stream for both the states and us. We are not sure but we put a conservative number into the budget, it's going to take the work of you the Region VP's and your states to make this work. Question? Mike Sawyer, what is the split and who will do the bookkeeping? The split will be 50/50 the bookkeeping as follows, ATS will provide us with the name of the people who participate by state breakdown, Treasurer Ed Hart #28991 will determine who has met the eligibility, payments will be by thresholds on a quarterly basis minimum. It is up to the individual Senator to advise ATS what state they wish the fund to go to. Vote on the motion, motion passes. Thank you by John Price #36383.
