## B. BY-LAW AMENDMENT TO ARTICLE IV

#### Proposed Amendments to Article IV - Individual Membership

Add:

Section 5 Any individual awarded a JCI Senatorship who resides in a state without an SOM affiliated with this corporation pursuant to Article V, or who relocates his/her residence to a state with an affiliated SOM that does not extend full membership to such individual, shall be eligible for membership in this corporation as a Non-Affiliated State Member (NASM). No individual who is a member of any SOM affiliated with this corporation shall be eligible to become or remain a NASM.

Section 6 NASMs shall not be eligible to run for elected office in this corporation.

Section 7 NASMs shall be eligible to hold appointed office in this corporation, to chair any committee or activity in this corporation, and serve as a member of any committee or activity of this corporation, of which the NASM is otherwise qualified to serve. NASMs shall be eligible to receive awards to which they otherwise would be entitled.

**Section 8** NASMs shall have voting privileges at meetings of this corporation only in their capacity as serving in an appointed position in accordance with Section 7.

**Section 9** NASMs are prohibited to organize themselves into groups or function as an affiliated SOM. NASMs shall not bid or host USJCI Senate events.

Section 10 Participation in region activities by NASMs may be limited by each region.

**Section 11** NASMs may join affiliated SOMs providing that such membership is not in conflict with the constitution or by-laws of the SOM. No SOM shall be required to offer or accept membership of a NASM.

# Proposed Amendments to Article V - State Organization Membership Add:

Section 5 The corporation shall maintain rosters of NASMs in each state without an affiliated SOM. At such time as the number of NASMs in any such state reaches twenty (20), additional applications for membership as a NASM in such state shall be denied and the corporation shall notify the twenty NASMs of the requirements of this Section. Within one hundred eighty (180) days of such notice, the twenty NASMs shall take all steps necessary to become a SOM chartered with this corporation in accordance with Article V.

Section 6 At such time as a group of NASMs in any state is chartered as an affiliated SOM of this corporation, the corporation shall reimburse the newly affiliated SOM with a sum of money equal to three-fifths (3/5) of the annual dues\_collected from NASMs residing within such state. Said reimbursement shall be made to the newly charted SOM within ninety (90) days of the date of charter of the SOM

## Proposed Amendments to Article VI - Dues

Add:

Section 8 The amount of dues assessed to and collected from NASMs shall be five (5) times the yearly dues assessed for individual members of SOMs under Article VI Section 1. Three-fifths (3/5) of such NASM dues collected annually shall be held in a separate fund during the year collected to be used in accordance with the provisions of Article V, Section 6. At the end of each fiscal year of this corporation, any monies in such fund that have not been used in accordance with Article V, Section 6 shall be paid over to the corporation's general fund.

Section 9 NASM dues shall be billed and collected once per year and shall be due on September 1. NASMs joining after September 1 shall have their dues prorated on a month basis.
