We have brought this down to \$25 per person so everybody can afford to attend and even sell some tickets in your state for those who can't attend. Let's make plans now to go to our biggest and best raffle yet. If 400 tickets are sold, we will make about \$7,000.

JCI Senate Study Exchange Program, Dave Habershaw, #17878, - Dave stated many more things need to be done yet before this program can be implemented, including approval by the US Jaycees and the Jaycee International, plus method of financing. Dave stated that if there was no interest in this program by the Senate, he did not want to go on with his investigation of it. After much discussion, a motion was made by Larry Sheeler, that the Senate enthusiastically support this program. Seconded, motion passed. Dave is to report to the Executive Committee on his progress at Tulsa.

Presidental Remarks, Tony Dominiec, #23393, - Tony thanked the Texas Senate and San Antonio Jaycees for their help in setting up this meeting. He plans to get the travel schedules of the past 3 National Presidents and go into the states that they were unable to visit. His goals for this year are to get more senators involved, and increase social activities for the senators. Next meeting will be in Tulsa on January 15-16-17. Thanked everyone for what they have done to date.

JCI SENATE STUDY EXCHANGE PROGRAM

Purpose: An educational activity in which two JCI Senate Organizations in different parts of the world, agree to exchange teams of from three to five Jaycees. One year the sending Group selects the team members, prepares them for their experience abroad, and arranges the travel plans. The following year the receiving Group becomes the sender. The visit may not last more than two weeks. The host Group develops an itenerary for the visiting team including a Jaycee project to work on and makes sure that all travel and lodging/meals are provided for during the visit. Funding for the visiting team's air travel will be arranged for by the sending Group. Spending money is the responsibility of the individuals selected for the visit.

Objectives: The JCI Senate Study Exchange will be an education and leadership training program designed to:

- A. Provide opportunities for outstanding young Jaycees to study and work on Jaycee projects with their counterparts in another country.
- B. Further International understanding by allowing young Jaycees (men and women who are actively involved) to talk, live and work on projects together with their counterparts in different parts of the world in a spirit of goodwill and friendship in order to better learn about and understand each others problems and aspirations;
- C. Involve JCI Senators and Senate Organizations in a specific practical and meaningful international service program by organizing educational programs for Group Study Exchange and providing hospitality for them; and
- D. Provide a meaningful and working program which will assist the US Jaycees and JCI further develop their Individual Development Programs for their memberships at large.

Group Study Teams: The JCI Senate Group Study Teams scheduled to make a visitation to another country will be made up as follows:

- A. A Team Leader who must be a JCI Senator and a dues paid, active member of one of the duly chartered SOMs (for the US).
- B. Three to five active Jaycees (men and women) who have been members of the organization for no less than three full years and have demonstrated through actual involvement, a sincere interest in furthering the principles of the Jaycee movement.
- C. Although it shall not be a requirement for selection, it will be desireable that the individual's demonstration of interest should include some type of involvement with Jaycees International programs. It shall be a requirement that the individual Jaycees and Senator Team Leaders being considered as participants, shall have attended at least one international conference (Either a World Congress; an Area Conference; or one of the many Intern'l Jaycees Conferences such as the European Conference).

Roll of states for purpose of nomination for Secretary. Alabama yields to Nebraska. Vic Kender nominated Lanny Heater, seconded by Arkansas, motion by Pat Lichter, seconded by Iowa, to instruct the Secretary to cast an unanimous ballot for Lanny Heater for Secretary, motion passed.

Roll of states for purpose of nomination for Administrative VP. Alabama yields to Indiana. Tom Selmer nominated Dave Habershaw, seconded by Dave Ingram, motion by Dave Ingram, seconded by Rhode Island, to instruct the Secretary to cast an unanimous ballot for Dave Habershaw for Administrative VP, motion passed.

Roll of states for purpose of nomination for President of US JCI Senate. Alabama yields to Oregon. George Fraser at this time withdrew from the race and released his delegates. Oregon then yielded to Illinois. Bill Willett nominated Jim Hall for President. Seconded by Ron Whitmore and Terry Opel. Alaska then yielded to Maryland. Steve Pindell nominated Larry Sheeler for President. Seconded by Wayne Avery, Allan Brock, and Jim Jumper.

Thirty-one states was roll-called. Then at this time Jim Hall moved for an unanimous ballot for Larry Sheeler for President, seconded by many. Motion passed.

Newly elected President, Larry Sheeler, thanked all the people who worked for him. He also thanked Jim Hall and George Fraser for their enthusiasm during this campaign. - Section 1 At the Corporations's Mid-year Meeting the President shall appoint, with the approval of the Executive Committee; a Nominating and Elections Committee of not less than three (3) or more than five (5) members in good standing: one member shall be the C.O.B., who shall serve as chair. No member of this committee shall be entitled to be nominated for any office.
- Section 2 In addition to the qualifications for candidacy as specified in these By-Laws, the following are requirements for candidates for any elective office, and the Nominating and Elections Committee shall publish and assure compliance with all qualifications and requirements for office:

A A letter of recommendation from the candidate's SOM.

B A completed official application form, as furnished by the

Secretary.

C A filing fee of fifty dollars (\$50) for Presidential candidates,
and twenty-five dollars (\$25) for all other candidates for election.

Filing fees are for deposite to the organization's general treasury,
and are not refundable under any circumstances.

- Section 3 Formal announcements of candidates for office shall not be made prior to the Friday evening of the Mid-year Meeting.
- Section 4 The Nominating and Elections Committee shall, at least sixty (60) days prior to the Annual Meeting, mail to all members of the Board of Directors:

A A copy of the Articles entitled "Officer", "Nominations and Elections Committee and Duties", and "Election Procedures and Voting" in these By-Laws.

B A list of currently announced candidates for office and their SOMs.

C A notice that items listed in sub-sections A, B, and C in Sect-

ion 2 of this Article must be filed with the Secretary by or on

behalf of, any Senator proposed for any elective office, by mail, post-marked no later than fifteen (15) day prior to the first business session of the Annual Meeting.

Section 5 The Nominations and Elections Committee shall also:

A Check qualifications of, and fulfilling of requirements by, each candidate, as specified in these By-Laws.

B Announce candidates for President, Administrative V. President, Secretary, and Treasurer, and encourage all Regions to nominate candidates for Regional Vice President.

C Certify and register accredited voting delegates from affiliated SOMs, and ascertain compliance with dues payment requirement as specified in these By-Laws.

D Formulate, publish, interpret and enforce election rules, subject to the approval of the Exec. Committee.

E Tabulate votes for offices of President, Administrative V. President, Secretary and Treasurer.

F Announce the results of all voting, including Regional Vice President election caucuses.

Section 6 Nominations from the floor for a specific office are accecptable provided there are no qualified candidates filed for that office, and provided such candidate conforms to the qualifications for, and requirements of, candidates for office as specified in these By-Laws, and provided further that filing fees for candidates nominated from the floor shall be double the amounts specified in Section 2,C of this Article.

ARTICLE IVI, ELECTION PROCEDURES AND VOTING:

- Section 1 No SOM shall be permitted to vote during elections unless its delegates have been duly certified by the Nominating and Elections Committee, and a SOM's dues shall have been paid in full by noon of the day of the Annual Meeting.
- Section 2 Nominations from the floor are acceptable as specified in the preceeding Article of these BY-Laws.
- Section 3 Only one five (5) minute nominating speech and one three (3) minute seconding speech shall be allowed on behalf of any candidate for the office of President; and only one three (3) minute nominating speech and one one (1) minute seconding speech shall be allowed on behalf of any candidate for any other elected office.
- Section 4 Only duly certified SOM delegates shall be eligible to vote, and each SOM shall have a maximum of two (2) votes as specified in these By-Laws. An SOM may split its vote, but no fractional votes nor absentee/proxy ballots shall be allowed. SOMs shall indicate their candidate preference by voice vote in an order determined by lot as organized by the Nominations and Elections Committee.
- Section 5 Officers shall not have a vote in their capacity in office, but may vote as a delegate of their SOM, if so certified.
- Section 6 The President, Administrative V. President, Secretary and Treasurer shall be elected by a simple majority vote of those certified delegates present and voting. Should there be more than . two (2) candidates for any of these offices, the candidate who

receives the lowest number of votes on two (2) consecutive ballots shall be automatically required to withdraw from that election, and the election shall proceed in such manner until two (2) candidates remain. Balloting shall then continue until one candidate is elected by a simple majority vote.

Section 7 Regional Vice Presidents shall be elected in Regional caucus, as specified in these By-Laws. Such caucuses shall be convened immediately prior to the elections for all other elective offices.
