#### TREASURER'S REPORT: by Bruce Geddes #35527.

- 1. <u>FINANCE COMMITTEE</u>: by Chairperson Vicky Dempsey #58206: The Finance Committee met and had a very productive meeting. Except for the Chair, all members of the committee are new. The Audit revealed no deficiencies and has been filed with the Historian. There was an \$11,048.00 surplus from last year and it is proposed by the COB Pat Hoelker #45893 and recommended by the Finance Committee that these funds be distributed as follows: \$4,000 to the 40<sup>th</sup> Anniversary Program, \$3,000 to the JCI BedNet Program, \$2,000 to the USJCI Senate Presidential Raffle to be used to purchase ten (10) \$200 gifts to be utilized as prizes with prize recognition as donated by the 2008-09 team, and \$2,048 to the USJCI Senate Foundation. The Executive Committee did not discuss nor take action on this matter. This recommendation was made into a motion by California, seconded by South Carolina and passed.
