Thanks to the Committee that is putting this on and to the hotel and staff. President Ariel then called on NVP Allan Richardson for a welcome to Region III.
- VIII. **Introductions:** President Ariel called on Protocol Officer Dawna Norfleet #61999 for the introduction of special guests including our Past Presidents. Due to COVID-19 there were no

international guests present. From JCI USA was our JCI Liaison and their 95th Past President Jennifer Ray #68957 and JCI USA 101st President Heather Danley #74897.

- A. **Mentors:** The Mentors Chief Editor Angie Jelinek #60570 gave thanks to President Ariel and Secretary Hal for their help this year. Also thanks to the Mentors team – John Cotter, Regina Cannelongo-Mahaney, Mary Allred, Jennifer Salmon, Newton Standridge, and photographers Yvonne Sewell and Eldon Bowers. - C. **Web Master:** Web Master Lowell Vahl #40315 said the report is on the web. Thanked everyone on the Exec Board and the Program Managers for getting their reports in. Those who have sent in your registration forms we appreciate your support. We have been trying to keep the website up to date with registration forms and calendar dates.
- D. **Social Media:** Social Media Director Kim Hubbell #68729 – How many people have liked our page? We have 347 people who have liked the page. Keep sending pictures to put on the page. Thanks to photographers who have sent pictures this year
- E. **Approval of the Minutes:** Copies of the minutes from the Mesa 2021 Winter Board Meeting were sent out electronically and were available in print at the back of the room. Motion to approve by Maryland. Second by Region VIII. Opened for discussion. Kelly Koch pointed out an error in Section X, item E, the location should be changed to Lawton 2020 Fall Board Meeting. Also on the last page it states the meeting was adjourned at 11:20 pm. That should be 11:20 am. Kelly Koch made a friendly amendment to correct these errors. Second by Arizona. No discussion on the friendly amendment. The friendly amendment passed. No other discussion on motion to approve the minutes as amended. Motion passed unanimously.
- X. Treasurer Report:** Treasurer Susan Hatcher #58143
- A. **Finance Committee Report** by Pete Reinecker #11777. They met Monday morning and reviewed the Budget to Actual. They did make one change and transferred \$250 from the First Ladies breakfast to the National Meeting Expense. We had a very large increase in income from the Presidential Sweepstakes this year. We are currently \$9,000 over the budgeted goal. We added \$2,500 into the Presidential Sweepstakes prize money. We had an area in the Donations category. There was money put in there that was money raised for the Outgoing President's Gift. It was deposited in the Donation category in error. We made a motion to show it as an erroneous deposit to allow the Treasurer to write a check and return the money to the depositor. We have \$3,500 budgeted for the Ambassadors travel. This past year they couldn't travel out of the country due to the pandemic. We moved to allow the Treasurer to reimburse the Ambassadors up to \$1,000 each for expenses related to attending our Board Meetings and Regional Meetings where they were promoting their areas. The next thing discussed was the Preliminary Budget which Susan will present to you later today. We will not vote on it today. It will be voted on at the Fall Board meeting in Wichita. The last item discussed was a Debit Card so the President and Treasurer have a debit card for emergency purposes. We weren't sure how to handle it, so we referred it to the Audit Committee.
- B. **Membership Report:** Gary Pittenger #24804 Report can be found on the web. It has the membership results for the year. There are two quarters of membership to repost since we last met at the Winter Board Meeting. We started out at +34 for the year. March took us down to +17 for the year. Three regions were at growth. The largest was Region IV at +14. The others

were Region V at +8 and Region III at +6. Twenty states grew, with the largest being South Carolina at +11. The next two were Virginia and Illinois tied at +5. In June we had 2,438 up for renewal. We dropped 156, but we added 196 for a net of +40. We had six regions grow with Region IV +34, Region II at +24, Region VIII at +14, Region V at +13, Region III at +6 and Region I at +1. Twenty one states grew with Texas at +23, Florida at +18, and New York at +14. That put us at +57 for the year with a total membership of 8,014 members. Twenty one states grew for the year. The top three were Texas at +23, Florida at +18 and New York at +14. Seven regions grew for the year. The top growth region was Region IV at +95 followed by Region VIII at +43, Region I at +13, Region V at +12, Region II at +7, Region VI at +3 and Region III at +1. We have 21 states that grew this year. The largest was Texas at +55 followed by South Carolina at +44 and Florida at +41. I appreciated working with the state Treasurer's this year. Getting the dues kits in on time makes it a lot easier on me and getting your checks in on time makes it a lot easier on Susan. I also want to thank my assistant this year, Lloyd Mueller.

C. Temporary 2021-2022 Budget: Treasurer Susan Hatcher #58143 said there are copies in the back of the room of the 2021-2022 Preliminary Budget. It was passed by the Finance Committee on Monday. That budget will be adjusted as necessary and approved by you at Fall Board in September.

XI. Administrative Vice President Report:: AVP Mike Andrews #58312

AVP Mike excused the National Vice Presidents to ready themselves for their reports later in the meeting.

A. Ambassador's Reports

Ambassador to ASAC: Steve Sutherland #27073 said the conference of the Americas was cancelled, but we did have the General Assembly on June 29th. At that time we had our elections. The new President of ASAC is Joy Braithwaite #70476 of Trinidad and Tobago. The Vice President is Victor Garcia "Pucho" Caban #30142 from Puerto Rico. The Director of North America and the Non-Spanish Speaking Countries in ASAC is John Robinson #55768. The Treasurer of ASAC is Lawrence Pittman #53932. President Joy is sorry she could not be here at this meeting. Trinidad is not opened up yet. They say they will open up in September. The next Conference of the Americas will be next May in Curacao.
